**2. Celebrations—**Mr. Shirley shared that our recent STEAM Night in January was a huge success, with a great turnout. The students were able to rotate from several stations and it was very impactful and enjoyable for families.

**3. Trustlands/ Student Needs/ Goal for 20-21 —**Mr. Shirley discussed staffing, budget allocation estimate, high class size reduction option for some grade levels, remaining budget, and website item compliance with the Council. He explained that we have a rough Projection of funds between \$90,000-100,000. The Council members also discussed class sizes for the coming year to determine the best needs to allocate funds. It was determined by the Council that Trustland funds will be utilized for the 2020-21 school year to purchase a full teacher, instead of a partial tor split teacher.
